**INSIDE INFORMATION – UPDATE ON LITIGATION OF
CIVIL ACTION AGAINST PEARL RIVER FILM PRODUCTION**

This announcement is made by Global Digital Creations Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcement of the Company dated 27 April 2021 (the “**Announcement**”) and the section headed “Management Discussion and Analysis-LITIGATIONS” of 2021 first quarterly report, interim report and third quarterly report of the Company dated 7 May 2021, 12 August 2021 and 5 November 2021, respectively, as well as the section headed “REPORT OF THE DIRECTORS – UPDATE ON LITIGATIONS” of the annual report of the Company dated 25 March 2022 (the “**Reports**”) in respect of the legal proceedings initiated by 廣東環球數碼創意產業有限公司 (“**Guangdong GDC**”), an indirect non-wholly owned subsidiary of the Company, against 珠江電影製片有限公司 (Pearl River Film Production Limited*) (“**Pearl River Film Production**”), claiming for the (i) return of capital contribution invested in the construction for the Pearl River Film Cultural Park and the related interests in the amount of approximately RMB240,000,000 and RMB54,900,000, respectively, and (ii) compensation on losses of RMB20,000,000 borne by Guangdong GDC arising from the said investment due to breach of contract by Pearl River Film Production (the “**Claims**”). Unless otherwise specified, capitalized terms used herein shall have the same meanings as defined in the Announcement and the Reports.

The Board wishes to inform the Shareholders and potential investors that, on 18 May 2022, a civil judgment (民事判決書) from the Guangzhou Intermediate People’s Court dated 12 May 2022 (the “**Civil Judgment**”) was handed down to Guangdong GDC. According to the Civil Judgment, the Claims have been rejected by the Guangzhou Intermediate People’s Court.

The Company is seeking legal advice in response to the Civil Judgment from the Guangzhou Intermediate People’s Court and will make further announcement(s) concerning further developments as and when appropriate.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
