INSIDE INFORMATION – UPDATE ON LITIGATION

This announcement is made by Global Digital Creations Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcement (the “**Announcement**”) of the Company dated 3 April 2019 and the section headed “MANAGEMENT DISCUSSION AND ANALYSIS – LITIGATIONS” of the 2020 interim report of the Company (the “**Interim Report**”) dated 12 August 2020 in respect of the legal proceedings initiated by 珠江電影製片有限公司 (Pearl River Film Production Limited*) (“**Pearl River Film Production**”) against 廣東環球數碼創意產業有限公司 (“**Guangdong GDC**”), an indirect non-wholly owned subsidiary of the Company, requiring Guangdong GDC to return the entire of 珠影文化產業園 (the “**Pearl River Film Cultural Park**”) and its facilities and related documents. Unless otherwise specified, capitalized terms used herein shall have the same meanings as defined in the Announcement and the Interim Report.

The Board wishes to inform the Shareholders and potential investors that, on 25 September 2020, a civil judgment (民事判決書) from the People’s Court of Haizhu District dated 24 September 2020 (the “**Civil Judgment**”) was handed down to Guangdong GDC. According to the Civil Judgment, Guangdong GDC shall return the entire Pearl River Film Cultural Park and its facilities and related documents to Pearl River Film Production. All other claims made by Pearl River Film Production were dismissed.

The Company is seeking legal advice in response to the Civil Judgment and will make further announcement(s) concerning further developments as and when appropriate.

The Board also wishes to inform the Shareholders and potential investors that the Group had derecognised the Pearl River Film Cultural Park as an investment property of the Group from 1 December 2018. The Board does not consider the Civil Judgment to have any material impact on the financial position and cash flow of the Group.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
