Unless otherwise specified, capitalized terms used herein shall have the same meanings as defined in the Announcement and the Interim Report.

The Board wishes to inform the Shareholders and potential investors that, on 25 September 2020, a civil judgment (民事判决書) from the People's Court of Haizhu District dated 24 September 2020 (the "Civil Judgment") was handed down to Guangdong GDC. According to the Civil Judgment, Guangdong GDC shall return the entire Pearl River Film Cultural Park and its facilities and related documents to Pearl River Film Production. All other claims made by Pearl River Film Production were dismissed.

The Company is seeking legal advice in response to the Civil Judgment and will make further announcement(s) concerning further developments as and when appropriate.

The Board also wishes to inform the Shareholders and potential investors that the Group had derecognised the Pearl River Film Cultural Park as an investment property of the Group from 1 December 2018. The Board does not consider the Civil Judgment to have any material impact on the financial position and cash flow of the Group.
