This announcement is made by Global Digital Creations Holdings Limited (the "**Company**") pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "**GEM Listing Rules**") and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcements (the "Announcements") of the Company dated 3 April 2019 and 28 September 2020, and the section headed "MANAGEMENT DISCUSSION AND ANALYSIS – LITIGATIONS" of the 2020 third quarterly report of the Company (the "Quarterly Report") dated 6 November 2020 in respect of the legal proceedings initiated by 珠江電影製片有 限公司 (Pearl River Film Production Limited\*) ("Pearl River Film Production") against 廣東環 球數碼創意產業有限公司 ("Guangdong GDC"), an indirect non-wholly owned subsidiary of the Company, requiring Guangdong GDC to return the entire 珠影文化產業園 (the "Pearl River Film Cultural Park") and its facilities and related documents. Unless otherwise specified, capitalized terms used herein shall have the same meanings as defined in the Announcements and the Quarterly Report.

The Board wishes to inform the Shareholders and potential investors that, on 20 February 2021, a civil judgment (民事判決書) from the Guangzhou Intermediate People's Court dated 8 February 2021 (the "Intermediate Court Civil Judgment"), being the final judgment, was handed down to Guangdong GDC. According to the Intermediate Court Civil Judgment, the Guangzhou Intermediate People's Court rejected the appeal from Guangdong GDC and the decision of the People's Court of Haizhu District was upheld. Accordingly, Guangdong GDC shall return the entire Pearl River Film Cultural Park and its facilities and related documents to Pearl River Film Production. All other claims made by Pearl River Film Production were dismissed.

The Company is seeking legal advice in response to the Intermediate Court Civil Judgment and will make further announcement(s) concerning further developments as and when appropriate.

As the Group had already derecognised the Pearl River Film Cultural Park as an investment property of the Group from 1 December 2018, the Board does not consider the Intermediate Court Civil Judgment to have any material impact on the financial position and cash flow of the Group.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
