INSIDE INFORMATION-UPDATE ON LITIGATION

This announcement is made by Global Digital Creations Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcement of the Company dated 31 March 2026 in relation to Institute of Digital Media Technology (Shenzhen) Limited*(環球數碼媒體科技研究(深圳)有限公司)(the “**Defendant**”), an indirectly wholly-owned subsidiary of the Company, received a civil summons from Guangzhou Intermediate People’s Court (the “**Announcement**”). Unless the context otherwise required, capitalised terms used in this announcement shall have the meanings as defined in the Announcement.

The Board wishes to inform the shareholders of the Company and its potential investors that the Defendant received a civil judgment (民事判決書) from Guangzhou Intermediate People’s Court on 31 August 2026 (the “**Civil Judgement**”).

According to the Civil Judgement, all the claims against the Defendant by 珠江電影製片有限公司 (Pearl River Film Production*) (the “**Plaintiff**”) in the sum of approximately RMB129.8 million was dismissed. Both parties have the right to lodge an appeal within 15 days from the date on which the Civil Judgement is served.

The Company will keep the shareholders and potential investors of the Company informed of any further material developments regarding the above litigation by way of further announcement(s) as and when appropriate in accordance with the requirements of the GEM Listing Rules.

Shareholders of the Company and potential investors should exercise caution when dealing in the securities of the Company.
