INSIDE INFORMATION – UPDATE ON LITIGATION

This announcement is made by Global Digital Creations Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcements (the “**Announcements**”) of the Company dated 3 April 2019, 28 September 2020, 23 February 2021 and 3 June 2021, and the section headed “MANAGEMENT DISCUSSION AND ANALYSIS – LITIGATIONS” of the 2021 interim report of the Company (the “**Interim Report**”) dated 12 August 2021 in respect of the legal proceedings initiated by 珠江電影製片有限公司 (Pearl River Film Production Limited*) (“**Pearl River Film Production**”) against 廣東環球數碼創意產業有限公司 (“**Guangdong GDC**”), an indirect non-wholly owned subsidiary of the Company, requiring Guangdong GDC to return the entire 珠影文化產業園 (the “**Pearl River Film Cultural Park**”) and its facilities and related documents. Unless otherwise specified, capitalized terms used herein shall have the same meanings as defined in the Announcements and the Interim Report.

The Board wishes to inform the Shareholders and potential investors that, on 13 October 2021, the Company received a civil judgment (民事裁定書) (the “**High Court Civil Judgment**”) from the Guangdong Higher People’s Court dated 18 September 2021, pursuant to which Guangdong GDC’s claim against the return of the Pearl River Film Cultural Park, the re-trial petitions of Guangdong GDC and the application to set aside the Intermediate Court Civil Judgment have been rejected by the Guangdong Higher People’s Court.

Based on the advice from the Group’s legal advisor and to the best of the knowledge, information and belief of the directors of the Company, the High Court Civil Judgment is final and binding on the parties.

As the Group had already executed the return of the entire Pearl River Film Cultural Park, its related facilities and documents to Pearl River Film Production in April 2021 pursuant to the Intermediate Court Civil Judgment, the Board does not consider the High Court Civil Judgment to have any material impact on the financial position and cash flow of the Group.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
